現有PFAS定量技術是分析PFAS物質的特定結構,但同碳數族群之PFAS酸及鹽類物質,其可被辨識的特定結構相同,因此無法區別所分析的特定結構是來自酸或者鹽類,故測試結果為同碳數族群之PFAS之酸及鹽類物質的濃度總合。下表PFAS物質濃度皆已包含在測試結果中,相關資訊請參見下表:(下表列舉PFAS物質僅為範例,並不包含所有同碳數族群之PFAS鹽類。)

(The quantitative technology of PFAS is to analyze the specific structure of PFAS substances. However, PFAS acid and its salts with the same carbon number group have the same specific structure that can be identified. The tested results of the analyzed specific structure cannot be distinguished to identify the contribution from PFAS acid or its salts. Therefore, the tested results display the sum of concentrations of PFAS acids and its salts with the same carbon number group. The concentration of PFAS substances in the below table have been included in the tested results, please refer to the table for relevant information: (The listed PFAS substances are examples only, it do not include all PFAS salts with the same carbon number group.))





多溴聯苯/多溴聯苯醚分析流程圖 / Analytical flow chart - PBBs/PBDEs









六溴環十二烷分析流程圖 / Analytical flow chart - HBCDD





鹵素分析流程圖 / Analytical flow chart - Halogen








