#### PFAS Remark:





#### 多溴聯苯/多溴聯苯醚分析流程圖 / Analytical flow chart - PBBs/PBDEs









#### 六溴環十二烷分析流程圖 / Analytical flow chart - HBCDD





#### 鹵素分析流程圖 / Analytical flow chart - Halogen








